What is the fund's objective?

The objective of the fund is to deliver high growth of capital and income, a reasonable level of current income and relative stability for capital invested to obtain long term wealth accumulation.

What does the fund invest in?

The fund is an actively managed multi-asset class mandate designed to reflect Melville Douglas's optimal long-term capital growth strategy. The fund focuses on delivering balance between investment returns and the risk associated with those returns, between capital growth and cash generation and balance between compound and cyclical price performers. The maximum equity effective exposure (including international equity) will not exceed 75% of the market value of the portfolio.

What possible risks are associated with this fund?

General market risks include a decline in property values, share price volatility, a change in interest rates and economic conditions. Where foreign securities are included in the portfolio there may be additional risks, such as potential constraints on liquidity and the repatriation of funds, macro-economic risks, political risks, tax risks, settlement risks, and potential limitations on the availability of market information.







Fund review

The Melville Douglas STANLIB Balanced Fund delivered a return of 5.7% relative to the benchmark return of 5.9% over the quarter. The performance from the fund's equity holdings detracted from the returns relative to our peer group.

Market overview

As at 30 September 2025, South Africa's FTSE/JSE All Share Index has delivered exceptional returns over the quarter, climbing 12.9%, outpacing the MSCI ACWI, which recorded an increase of 4.5% in Rand terms, this despite external headwinds of the 30% tariff imposed by the United States (US) on certain South African (SA) exports. However, this market exuberance stands in stark contrast to the challenges facing SA Inc., where GDP growth remains subdued despite rising 0.8% quarter-on-quarter in 2Q25. A closer examination of the JSE rally reveals that it has been largely driven by non-SA Inc factors, namely, i) the cyclical strength in commodities with notable gains in precious metals. Gold surged by c.46%, fuelled by safe-haven demand, renewed investor inflows via ETFs amid a broader trend of diversification from US assets, a weaker US Dollar (USD), driven by expansive fiscal policy and monetary easing and heightened policy uncertainty. Platinum reached an all-time high of \$1620/oz (c.80%), underpinned by expectations of a sustained market deficit for the third consecutive year; and ii) robust performance in technology counters such as Naspers and Prosus. Meanwhile, the banking sector, often viewed as a bellwether for domestic sentiment, posted a modest gain of 0.9%, underscoring the disconnect between equity market performance and the real economy. Emerging Markets posted gains of 7.4% in Rand terms, supported by broad-based USD weakness. SA Bonds recorded gains of 6.9%. The Rand demonstrated notable resilience reaching a 10-month high of 17.24 to the USD in September, its strongest level since July 2024. This appreciation was largely driven by USD weakness and investors' increased appetite for risk assets. SA's GDP expanded by 0.8% in the second quarter of 2025, marking the fastest sequential GDP growth in the last two years. Looking ahead, we maintain a cautiously optimistic outlook. We expect a gradual improvement in GDP growth, underpinned by the ongoing stabilisation of electricity supply, steady progress in structural reforms, particularly in critical infrastructure sectors and stronger oversight from the newly formed Government of National Unity (GNU). Despite persistent policy uncertainty and heightened geopolitical tensions, the global economy demonstrated commendable resilience. This momentum is expected to continue over the medium term, underpinned by increasingly supportive monetary and fiscal measures across major economies, including the US, Germany, and China. Financial conditions have eased meaningfully, reflected in record-high equity market levels and narrowing credit spreads to historic low levels. The US Federal Reserve implemented its first rate cut of the year, citing emerging softness in the labour market and potential political considerations

Looking ahead

Amid a volatile global backdrop, domestic and global economic activity has remained more resilient than expected. Structural reforms continue to underpin SA's long-term economic strategy. While progress under Operation Vulindlela has been gradual, the trajectory remains encouraging. We maintain our conviction that these reforms will foster a more inclusive and resilient economic growth over time. Strong export commodity prices and the projected easing of interest rates will provide support to economic activity and asset classes. That said, valuations for the SA equity market continue to be attractive, underpinned by EPS growth over the next two years, which is expected to be 12-15%, benefitting from favourable base effects and higher precious metal prices. Global earnings revisions have largely stabilised, with notable improvement in the US, driven by stronger forward guidance from large-cap technology companies. While the full impact of elevated tariffs is yet to be felt, recent developments, particularly the Liberation Day announcements, have reduced downside risks. Looking ahead, we anticipate a broadening of earnings growth across sectors, which should provide a constructive backdrop for risk assets. In conclusion, our investment strategy remains unchanged. We will continue to invest in high quality businesses that have wide and sustainable moats, that have the ability to deliver attractive compound cashflow growth through business cycles, at compelling valuations.
